# **JUSTIFICATION FOR NON-RECURRING & RECURRING EXPENDITURE**

### A. NON-RECURRING

#### 1. Land (Enhancement of compensation)

Some of the farmers have filed writ petitions in the Hon'ble District Courts for enhancement of compensation of land. It is expected that Hon'ble District Court may decide the cases in favour of farmers and ask the college to deposit the amount for payment to the farmers. Therefore, an amount of Rs.10.00 lacs has been proposed in this budget.

### 2. Buildings

#### i) Auditorium

In the last meeting of Finance Committee, a provision of Rs.370.00 lacs was made in the budget for the financial year 2008-09. The item was to be discussed in the meeting of Board of Governors and accordingly, the matter was taken up in the 8th meeting of Board of Governors held on 03.1.2008. and resolved to approve a committee consisting of Sh. Naresh Nagpal, ADTE/IT, Punjab, Chandigarh, two senior faculty member in Civil Engineering form GZS CET, Bathinda and one faculty member from Punjab Engineering College, Chandigarh. The committee will review the estimate got prepared by the College from the M/S NBCC, Ltd, which appear to be a on higher side. The matter was also discussed in detail in the 13th meeting of Building & Works Committee of the college which was held on 03.04.2008 vide agenda Item No. 13.4. It was resolved to ask M/s NBCC Ltd. for fresh and updated revised estimate on turn key basis. It was also decided to ask PWD V&R to submit and estimate alongwith drawings for the construction of Auditorium, on turn key basis. After receipt of estimates from both the organizations, the same will be sent to the committee under the Chairmanshiop Sh. Naresh Nagpal, Additional Director, Technical Education, Pb. The committee will then put up the complete details to Hon'ble Technical Education Minister cum Chairman Board of Governors for approving the agency from which the construction of the Auditorium is to be got executed. The matter regarding the taking of fresh estimate for the construction of auditorium alongwith drawings on turn key basis has been taken with the above said agencies. The estimates were submitted by the aforesaid agencies. The decision to approve the agency from which the construction works of the auditorium is got executed is still awaited. Therefore, a provision of Rs. 370 lacs has again been proposed for the financial year 2009-10.

# ii) Construction of Parking Shed.

A provision of Rs.10.00 lacs for construction of parking shed was made in the budget for the financial year 2008-09 as this item was approved in the 11<sup>th</sup> meeting of Buildings & Works Committee held on 29.3.2006. The parking shed could not be constructed in the year 2008-09 and it is expected to be constructed in the next financial year i.e. 2009-10. Therefore, a provision of Rs.10.00 lacs has again been made in this budget.

### iii) Construction of incomplete staff houses.

A provision of Rs. 35.00 lacs has been made in this budget for the construction of incomplete staff houses. The work has been started after the getting the approval in the 13<sup>th</sup> meeting of Building & Works Committee which was held on 03.04.2008 vide agenda Item # 13.6. The M/s NBCC has raised the bill approximately amounting to Rs. 13.00 lacs. Payment may be released after the approval of the budget and Rs. 22.00 lacs have been shown in this budget under buildings head.

# iv) Campus Development

A provision of Rs.25.00 lacs has been made in this budget for the campus development such as earth filling, improvement of landscaping and street lighting etc. in the campus.

Keeping in view the most essential requirement of the laboratories in the year 2009-10, a provision of **Rs.61.07 lacs** expenditure has been made in this budget as detailed below:

#### 6. Library

A provision of Rs.25.00 lacs has been made in the regular budget for purchase of text books, hand books, reference books including the purchase of Library Software and Rs. 13 lacs for providing the E-Resource (E-Journals facility and Furniture to meet the requirement of various courses as per AICTE New Delhi for running six B. Tech. courses and two M.Tech. courses.

# 7. Medical Equipment

To meet the essential requirement for the operation of the Health Centre of the College, a provision of Rs.1.00 lacs has been made in this budget.

# 8. Sports/Music/Audio Visual Equipment

For meeting the expenses in sports/music/audio visual equipment, a provision of Rs.3.00 lacs has been made in this budget.

# 9. Hostel Equipment including kitchen equipment

At present, there are five hostels in the college and to provide the essential equipment, including kitchen ware, a provision of Rs.2.00 lacs has been made in this budget.

### 10. Office Equipment

For the purchase of photocopiers-cum-printers, water coolers, display boards, a provision of Rs.10.00 lacs has been in this budget.

#### 11. Corpus Fund

As per the decision of the 16<sup>th</sup> meeting of Finance Committee, a provision of Rs.100.00 lacs has been made for Corpus Fund in this budget.

#### RECURRING

A sum of **Rs.715.00** lacs has been provided in this budget to meet the recurring expenditure during the year 2009-10.

#### Pay & Allowances

A provision of Rs.700.00 lacs has been made in this budget for the year 2009-10 including the arrear on account of revision of Pay Scale subject to the implementation of 5<sup>th</sup> Pay Commission report submitted by Govt. of Punjab & enhancement of D.A. in this year 2009-10. The detail of pay and allowances is placed at **Annexure-II** from page 5 to 9.

#### TA/DA & LTC

A provision of Rs.6.00 lacs has been made in this budget for the year 2009-10 for TA & LTC for the faculty and staff of the college.

#### **Medical Reimbursement**

A provision of Rs.4.00 lacs has been made in this budget for the year 2009-10 for meeting the medical expenses for indoor treatment of the employees of the college.

Reimbursement of Registration Fee for Conference, Seminars and Short Term Courses A provision of Rs.5.00 lacs has been made in this budget for the year 2009-10 for meeting the expenses on reimbursement of registration fee for conference, seminars and short term courses to the faculty.

#### Contingencies

To pay the wages of casual employees, electricity charges, maintenance of equipment and other miscellaneous expenses, a provision of Rs.210.50 lacs has been made in this budget under different heads.

To approve the budget for construction of incomplete staff houses.

The matter for the construction of incomplete staff houses was taken up in the 13<sup>th</sup> meeting of Building & Works Committee of the college which was held on 03.04.2008 under the Chairpersonship of PSTE/IT, Punjab. The item has been approved Agenda Item # 13.6. The minutes of the meeting are reproduced as under:

"It was resolved to approve the item subject to the availability of funds with the college." A copy of minutes of meeting in placed at Annexure—IV from page 31 to 34.

After the approval of the construction work of incomplete houses from the Building & Works Committee, the construction of staff houses was started by the M/s NBCC, Ltd. The expenditure expected to be the incurred is Rs. 35 lacs (approximately). The NBCC, Ltd., has submitted the running bill amounting to Rs. 1273427.11. A copy of bill is placed at **Annexure-V** from page 35 to 45.

Item # 20.6 To approve the fee structure for the admission in 10+1 (Non-Medical) stream for the opening of Beant Senior Secondary School under NABARD Scheme of Punjab Govt. in a academic year 2009-2010.

The college is going to establish Beant Senior Secondary School under

The college is going to establish Beant Senior Secondary School under NABARD Scheme of Punjab Govt. (Multi Disciplinary Academy) in the campus of Beant College of Engineering & Technology, Gurdaspur. The students will be admitted in the 10+1 and 10+2 stream (Non-Medical) and same is to be got affiliated with Punjab School Education Board, Mohali through DTE/IT, Punjab, Chandigarh The 10+1 (Non-Medical) classes will be started in this academic session 2009-10. The fee structure for the admission of the students in 10+1 (Non-Medical) stream has been estimated. Tution Fee of Rs. 855/- per month after considering the all aspects i.e. monthly remuneration of the Teaching Faculty appointed on hourly basis or taking the services of existing faculty for teaching of the said classes on lecture basis as well as remuneration of Non-Teaching staff was also taken into consideration. Keeping in consideration of above facts, the monthly fee Rs. 1000/- has been proposed for approval. As the students are being admitted in 10+1 (Non-Medical) stream will be subsequently promoted to 10+2 stream in the next year 2010. Hence, fee structure including PSEB examination fee for 10+2 will be proposed in the next year. A copy of fee structure is placed at **Annexure-VI** from page 46 to 47. It is further submitted that for the making of adhoc arrangement of teaching of classes in the said school, the consent of the existing faculty in the college will be taken to teach various subjects ass Physics, Chemistry, Mathematics, English, Punjabi and Computer to the students of 10+1 (Non-Medical) stream. A honorarium of Rs. 250/-(per lecture of 45 minutes) for the theory classes and Rs. 125/- (per hour) for a practical class of two hours is proposed.

Chandigarh. The PSEB, Mohali has sent the letter No.PSEB-F/2009/938 dated 02-03-2009 vide which the Board has asked for the depositing of affiliation fees Rs. 10,000/- and refundable security amounting to Rs. 75,000/ The copy of letter received from the PSEB is placed Annexure No VII from pages 48 to 49. To meet the pre-operative expenses for the starting of 10+1 (Non Medical) stream. It is proposed to transfer the returnable loan amounting to Rs. 2.00 Lacs from Beant College of Engg. & Technology, Gurdaspur to Beant Senior Secondary School, Gurdaspur.

Since, the inception of the college, the college Training & Placement Cell is managed by giving the additional charge to Professors/Assistant Professors/Lecturers of the college. In present scenario the placement in our Engineering College is facing very stiff competition from the private Colleges and Universities. To compete with the private sector, the Training & Placement Officer has to give some extra time and energy for the better placement of students. Hence, it is proposed that remuneration amounting to Rs. 1000/- or free accommodation in the Campus may be given as incentive for performing the additional duties till the joining of regular Training & Placement Officer in the college. It is also informed that College is already providing free accommodation to Chief Warden & Wardens of all five Hostels. Submitted for consideration & approval please.

Item # 20.9 To approve for the providing of Mobile Telephone facility in place of existing BSNL Landlines Connections to the HOD's/Coordinators/Section Inchages.

The college has already provided the BSNL land lines facility to respective HOD's/Coordinators/Section Incharges. The monthly telephone bill in some of above said HOD,s/Coordinator/Section Incharges of the departments comes more than Rs. 500/- per month. To minimize the expenditure on telephone expenses and easy availability of the concerned HODs/Coordinator/Section Incharges, it is proposed that the S.I.M Card to the name of respective department HOD,s/Coordinators/Section Incharges may please be provided under corporate scheme and the monthly Mobile telephone bill may be fixed Rs. 300/- per month or as actual bill whichever is less, is to be paid by the college on the submission of the bill by the concerned HOD,s/Cordiantors/Section Incharges
