#### Item No. 16.04

Restoring of financial assistance/grant-in-aid to Beant College of Engineering & Technology, Gurdaspur-regarding.

#### **Decision**

The Board has discussed that

- (a) Beant College of Engineering and Technology, Gurdaspur, was established by Govt of Punjab. As per Punjab Govt Letter No. PA/DTE/3666 dated 22.12.1994, the college is fully funded by Govt of Punjab and its annual recurring and non-recurring expenditure would be fully met by the Punjab Govt.
- (b) The college was getting annual grant from Govt of Punjab continuously till 2001 to meet its recurring and non-recurring

expenditure.

- (c) After the year 2001, annual grant of privately managed and aided engineering colleges and polytechnics were reduced 25% and subsequently stopped in the year 2004 as per the directions of Department of Finance vide Endt No. 1/14/2001-2ivK2/ 2481-83 dated Chandigarh 19.03.2001 and the same notification was also implemented on BCET, Gurdaspur.
- (d) Subsequently, annual grant of four privately managed & funded polytechnics was restored by the Govt of Punjab vide Endt No. 1/12/2001-4TE2/328-31 dated 26.02.2004. However, annual grant of BCET, Gurdaspur was not restored on the same pattern, due to which the financial position of this college started weakening.
- (e) In the present scenario, it is not feasible to run this college from the fee collected from students.
- (f) During recent audit, officials of A.G. Punjab have pointed out that recurring and non-recurring expenditure of the college are to be met by Govt. of Punjab and efforts should be made to get the grant released from Govt. of Punjab.

Keeping in view the above said facts, the Board has decided that Hon'ble Chairman BOG should write a DO letter to Hon'ble Finance Minister, Punjab, for restoring Grant-in-Aid to all state managed engineering colleges of Punjab. A fair draft of DO Letter should be put up to Hon'ble Chairman BOG through the office of DTE/IT.

Action Fair draft of DO letter was sent to the office of DTE vide letter no. BCET/1083, dated 20/3/2019 (Copy at Annexure Page 67).

# Item No. Regarding withdrawal of benefits due to non recognition of degrees obtained from Deemed to be Universities through distance mode

In response to DTE & IT letter memo no. 1107-1113/S-6/ECC/2018 dated 02/08/2018 (copy enclosed at Annexure pages 72 to 73), the college had sent the names of 20 faculty/staff members along with the details of their degrees obtained from Deemed Universities through distance mode/study centre/ off campus after year 2001 (copy enclosed at Annexure pages 74 to 76). The office of DTE & IT vide its letter memo no. 537/S-6/ECC/2019 dated 30/04/2019 has sent the approved report of committee constituted at their level regarding withdrawal of benefits due to non recognition of degrees obtained by some of the faculty and staff members through distance mode. A copy of letter dated 30/04/2019 received from the office of DTE/IT is placed at Annexure Pages 77 to 80.

Accordingly, item is placed before the Board for necessary approval regarding withdrawal of benefits of listed employees and removal of the entry of their degrees from the service books.

## Item No. Clarification Regarding TA/DA 17.04

An item no. 16.09 was put up in the 16<sup>th</sup> meeting of B.O.G for payment of TA/DA to faculty and staff. In said meeting it was decided to pay TA/DA as per the current TA/DA rules of IKGPTU, Jalandhar.

It is informed that IKGPTU, Jalandhar is giving T.A @ of Rs. 16/- per km for taxi and for journey by own car for performing academic and other Govt. duties. The current Punjab Govt. T.A rates are Rs. 7/- per km for taxi and Rs. 6/- per km for journey by own car.

The decision of 16<sup>th</sup> meeting of B.O.G was implemented in the college and started paying TA @ Rs.16/- for PTU related duties. However, there is confusion whether to pay TA @ Rs. 7/- for taxi and Rs. 6/- for own car or @ Rs.16/- (taxi and own car) for performing Punjab Govt. related duties as being paid by IKGPTU Jalandhar.

Matter is put up before B.O.G for necessary directions.

A letter memo no. 518-19/S-1/ECC/2017 dated 05/05/2017 has been received from the office of DTE/IT to give the benefits of CAS from Stage 1 to Stage 2 (i.e. AGP 6000 to 7000) and Stage 2 to Stage 3 (i.e. AGP 7000 to AGP 8000) by calling the meeting of Screening-cum-Evaluation committee (copy enclosed at Annexure pages 81 to 82). Accordingly, Screening-cum-Evaluation committee meetings were held on dated 26-05-2017, 27-05-2017, 29-05-2017 and 08-07-2017 for giving CAS benefits to faculty members from Stage 1 to Stage 2 (i.e. AGP 6000 to 7000) and Stage 2 to Stage 3 (i.e. AGP 7000 to AGP 8000). Further, the recommendations of screening cum evaluation committee meeting held at college level regarding CAS benefit to faculty members from Stage 2 to Stage 3, were sent to the office of DTE &IT, Chandigarh vide letter no BCET/Estt/2018/1012 dated 22/03/2018 (Annexure at page 83). Subsequent to these recommendations, a letter memo no. 967/S-4/ECC/2018 dated 11/07/2018 was received from the office of DTE & IT (copy enclosed at Annexure page 84). Therefore the CAS benefits were given to the faculty from Stage 1 to Stage 2 (i.e. AGP 6000 to 7000) and Stage 2 to Stage 3 (i.e. AGP 7000 to AGP 8000) vide letter no. BCET/Estt/2018/5397 dated 03/08/2018 (copy enclosed at Annexure Page 85 to 86).

# Item No. Appointment on compassionate grounds to son of late Sh. Raj Kamal, 17.07 Maintenance Attendant

It is intimated that Sh. Raj Kamal, who was working as maintenance attendant, was expired on 18-04-2019. Smt. Simran wife of late Sh. Raj Kamal, has requested for giving job to her son on compassionate grounds. (Copy of request & Death Certificate attached at Annexure pages 90 to 91).

Sh. Raj Kamal had joined this college as Maintenance Attendant on 25-10-2011 on regular basis and prior to his death, he was working on the same post in the pay scale Rs. 4910-20200 + 1650/- and drawing basic pay Rs.10590/- (Annexure Page 92).

As per chapter-2 under clause 2.3 of the college Bye-laws (Annexure Pages 93 to 94), the provision of giving employment on compassionate grounds is reproduced as under:

"Subject to availability of a suitable vacancy, one dependent of any employee of the college who dies or becomes permanently disabled while in service of the college be given employment in the college subject to his fulfilling the qualifications".

As per Sr. no. 8 of notification No. 11/105/98/4PP-II/14420 dated 21-11-2002 issued by Govt. of Punjab, Department of Personnel (Personnel Policies-II Branch), scheme for compassionate appointment-2002 (Annexure Pages 95 to 101), elder son of late Sh. Raj Kamal, Mr. Karan Kumar who is the claimant for the employment on compensation ground, is dependent member of the family. As per the documents provided by the family, the age of Mr. Karan Kumar is eighteen years and his qualification is 10+2 pass (Annexure Pages 102 to 103) and he is eligible for the post of maintenance attendant.

Therefore, it is proposed to appoint Mr. Karan Kumar S/O Mr. Raj Kamal as Maintenance Attendant in the pay scale of Rs. 4900-10680 with G.P Rs.1650/-.

To cater the need of academic appraisal of faculty/employees of various educational institutes/ industries/ organizations, Beant College of Engg. & Technology, Gurdaspur has applied for the establishment of IKGPTU, Kapurthala Regional Centre and commencement of M.Tech. Part Time courses in Chemical Engineering, Computer Science & Engineering, Electronics & Communication Engineering, Environmental Science & Engineering and Mechanical Engineering with an intake of 25 in each of the courses. The Expert Committee of IKGPTU visited BCET Gurdaspur on 03.05.2019 and has recommended commencement the abovementioned courses and intake. All the rules and regulations of IKGPTU, Kapurthala for the above courses will be implemented in Toto. It is worth to mention here that no extra faculty/infrastructure are required for the running of above courses. Also the financial requirement required for the payment to the faculty engaged for the above mentioned courses will be borne by IKGPTU, Kapurthala.
